### III. Reports:

- A. School Director Report
  - 1. Monthly Updates (Finances / Facilities / Enrollment / Staffing)

Justine C, Susan P, and Jim W met over the past couple of days for a leadership team work session which included work on the school curriculum, staffing, handbooks, budget, and facility acquirement.

Discussions with the Caviat superintendent are underway regarding the potential leasing of space. The Caviat building has possible space for 3 classrooms and grounds for modulars. There will be a Caviat board decision tomorrow regarding its availability. If a lease agreement is reached GCOA will establish its home office at Caviat beginning August 1, with more staff starting in Sept '21. More staff will be hired in August pending facility procurement. Until then, GCOA will remain in its current planning phase.

The building west of Caviat may also come available soon for lease. Jim W sent an email to the City of Page requesting a leasing agreement for four acres (for outdoor classrooms) with the option to own. An application will be sent to an architectural firm for building plans and architecture possibilities.

- 2. Discussion and approval of vouchers and/or related items. Not available.
- 3. Report from Justine Carryer on visits to Silverton School and Roots and Wings School.

Silverton, CO is a small town in a remote mountainous area and its school is a full EL school (expeditionary learning). This impressive school is 15-20 years old and incorporates expeditions into its curriculum along with social emotional learning. It has excellent lessons and its teachers have been there 10 plus years with the desire to spend their careers there. Justine plans to meet next week with the Silverton Head of School to establish a partnership with GCOA. Justine has also been in conversation with the EL national program.

Roots and Wings is located in Lama, NM in Taos County. It is a rural EL inspired charter school with new leadership. The cofounder will be in contact with Justine soon. Although there is a less cohesive atmosphere at this school compared to Silverton because of a recent reorganization, Justine will continue to maintain a dialogue with school administration and teachers for research purposes and to establish a relationship for GCOA. Roots and Wings has a strong math, science, and social studies curriculum, and has accomplished the restoration of wetlands in their area with the longest lasting water quality testing program anywhere in New Mexico.
