Discussion and possible action to approve an addendum to our EL Education contract – Justine Carryer

Gwen Lasslo moved to discuss Item 3, Justine Carryer seconded the motion. Motion approved.

The contract for this year ends in September. GCOA receives support services from EL Education. This is a change in training services and adds \$300.00 to the budget.

Gwen Lasslo moved to approve the addendum to our EL Education contract, Justine Carryer seconded the motion. Motion approved unanimously.

4. Discussion and possible action to approve the GCOA math, ELA and Expedition curriculum – Justine Carryer

There are three major components of the curriculum. GCOA is an EL school based on six 6wk thematic units. Math is supported by Discover Wild curriculum; ELA is EL Education curriculum; Expedition curriculum includes science and social studies, along with field work and community service projects.

Gwen Lasslo moved to approve the GCOA math, ELA and Expedition curriculum, Susan Pilkington seconded the motion. Justine Carryer abstained from voting. Motion approved unanimously (3 possible votes)

Susan Pilkington moved to approve the MOU with Juvenile Probation to accept Juvenile probation youth to perform community service under GCOA supervision only after hours (no students present), Gwen Lasslo seconded the motion. Motion approved unanimously.
